NBPHE to Launch Certification Program for Disease Intervention Specialists

WASHINGTON, D.C., October 21, 2022 - The National Board of Public Health Examiners (NBPHE) is proud to announce that the Centers for Disease Control and Prevention (CDC) has funded the development of a certification program for Disease Intervention Specialists (DIS). The DIS Certification Program is supported by the CDC through a Cooperative Agreement awarded to the Association of Schools and Programs of Public Health (ASPPH) and sub-awarded to NBPHE. The goal of the DIS certification is to improve public health services provided to communities by DIS through a high quality, standardized approach to the professional development of this workforce. Certification can standardize and validate the knowledge, skills, and abilities of DIS; drive the standardization and improvement of training; increase the quality and consistency of service delivery; and increase recognition of the skills and abilities of DIS.

The DIS certification will be the second certification offered by the National Board of Public Health Examiners. It also manages the Certified in Public Health (CPH) certification, available to those with either a CEPH-accredited graduate degree in public health or those with another degree and prior work experience in public health. Since 2008, over 11,000 public health professionals have earned the CPH credential.

It is anticipated the DIS certification program will be available by 2025. Eligibility criteria, exam content and recertification requirements are under development.
